AB 328 had been modified to no longer require independent contractors to carry insurance for the State of Nevada. He will continue to monitor this Bill on behalf of the Board.

SB 219 is being opposed by the Board and now Tanning bed facilities as well. Mr. Finseth indicated that emails from members of the Podiatric Medical Association should continue being sent in opposition to this Bill.

SB 509 had been amended significantly to just include operators of in home facilities and not healthcare providers as a whole.
