## NOTICE OF WORKSHOP FOR THE ADOPTION OF REGULATIONS OF THE NEVADA STATE BOARD OF PODIATRY

NOTICE IS HEREBY GIVEN that the Nevada State Board of Podiatry will hold a public workshop at 6:00 p.m. on Monday April 1, 2019 at 1325 Airmotive Way, Suite 175-I, Reno, Nevada 89502 and telephonic access Call-In Number: 866-632-4022 Access Code: 5194675088. The purpose of the workshop is to receive comments from all interested persons regarding the potential adoption of regulations that pertain to chapter 635 of the Nevada Administrative Code.

The purpose of the proposed regulations is to set minimal standards of education or training, including the taking and developing of X-rays, by trainees who wish to become podiatry hygienists. A copy of the proposed language that will be considered by the Nevada State Board of Podiatry is attached hereto.

Persons wishing to comment upon the proposed action of the Nevada State Board of Podiatry may appear at the scheduled public workshop or may address their comments, data, views, or arguments, in written form, to Carolyn Cramer, Executive Director, 1325 Airmotive Way, Suite 175-I, Reno, Nevada 89502. Written submissions must be received by the Nevada State Board of Podiatry on or before March 29, 2019. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Podiatry may proceed immediately to act upon any written submissions.
