spreadsheet with the list recommended for removal and the ranking that will be considered by the Nevada State Board of Podiatry and a copy of a spreadsheet with all of NAC Ch. 635 and the Board's consideration of each section are attached hereto. Additionally, a copy of the draft regulations proposed for removal is attached hereto.

Persons wishing to comment upon the proposed action of the Nevada State Board of Podiatry may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to Carolyn Cramer, Executive Director, 1325 Airmotive Way, Suite 175-I, Reno, Nevada 89502. Written submissions must be received by the Nevada State Board of Podiatry on or before March 1, 2023. If no person who is directly affected by the proposed removal of the regulations appears to request time to make an oral presentation, the Nevada State Board of Podiatry may proceed to immediately to act on any written submissions.
