As set forth in Executive Order 2023-003, the Board has been directed to review its regulations (NAC 635) and identify at least ten (10) regulations for removal. The purpose of this workshop is to review the Board's proposed recommended changes, solicit input as to the merits of those changes; and identify other regulatory changes members of the public feel are worthy of consideration regarding the potential to streamline, clarify, reduce or otherwise improve regulations that pertain to Nevada Administrative Code Chapter 635. Public comment received as a result of this Workshop will be part of the consideration of the Board when deciding to submit their proposed regulations to the Legislature for removal. The following regulations are to be considered for removal:

- Removal of NAC 635.100 Appearance by members of Board's staff- redundant by NRS 622A.300
